Legal Advocacy Basics:

Two Prohibitions for 501c3 Nonprofits (Public Charities Only):

- Electioneering (Candidate Elections Only)
- Excessive Lobbying (More than a substantial part)

Private Foundations vs Public Charities


- Private Foundations may not fund or engage in lobbying
- Public Charitable Foundations may do both
- Private Foundations may fund organizations that engage in lobbying as long as the amount funded does not exceed the non-lobbying portion of the funded activities

Other Funding Prohibitions:

- Federal funds, including any matching funds, cannot be spent on State or Federal Legislative or Executive Branch lobbying.
- State contracts may have prohibitions on the use of funds, but there is no general prohibition.

Know When Advocacy Becomes Lobbying:

- Advocacy becomes direct lobbying when:
 - Communication or action is aimed at a covered individual; and
 - It references a particular legislative action; and
 - It expresses a view on the action.
- Advocacy becomes grassroots lobbying when:
 - o Communication or action references a particular legislative action; and
 - It expresses a view on the action; and
 - It includes a call to action.
