

2023 Exploratory Grant Guidelines and Application – Fiscally Sponsored Entities

As part of the 2023 Tauck Family Foundation Exploratory Grants process, the Foundation will consider applications from fiscally sponsored organizations or entities. Before you begin, we strongly encourage you to review the <u>Eligibility Checklist</u> to determine whether your organization is a match for our funding opportunity. If your organization has current 501(c)(3) status in the United States, please complete <u>this application</u>.

Grant Guidelines:

About the Tauck Family Foundation	The Tauck Family Foundation (TFF) is a private, multigenerational family foundation founded in 1994 by Arthur C. Tauck, Jr. to foster a legacy of giving and community involvement. For over 25 years, the Foundation has supported youth development and in the last ten years has invested in organizations and initiatives within Bridgeport, CT. In September 2022, the Foundation announced an anticipated mission change to the environment sector and has spent the past year in an educational phase to arrive at a new vision, mission, and long-term outcomes, outlined below.
Our Vision	The land and natural habitats upon which communities and all living beings depend are healthy, regenerative, and valued.
Our Mission	The Tauck Family Foundation supports communities that are most impacted by climate and environmental challenges to strengthen and maintain healthy, regenerative ecosystems and land use practices through education and engagement.
Our Values	The Foundation seeks to support values-aligned organizations.
Integrity	We approach our work with humility and an awareness that we do not have all the answers. We aim to form strong, trusting relationships with our partners marked by transparency, spirited communication, and authentic connection.
Innovation	As a foundation committed to forward-thinking, we embrace innovative, entrepreneurial solutions to social and environmental problems. We seek to work with values-aligned partners towards mutual goals that ultimately contribute to a thriving community.

Growth Mindset	We value continuous learning and improvement in order to serve the needs of our ever-evolving world. We engage with colleagues and partners with varying perspectives, maintain a curious and open mindset, and use our learnings to continually iterate the way we approach and do our work.
Commitment to Excellence	We are committed to instilling a purpose in all that we do. We hold ourselves to high standards, and welcome challenges as opportunities for learning and growth.
Long Term Outcomes We Seek	Regenerative ecosystems and practices are valued as critical for long-term environmental and community health; -and-
	Communities that are most impacted by climate and other environmental challenges have tools, knowledge, and resources to address adverse impacts.
Our Approach	In 2023, the Tauck Family Foundation plans to distribute several exploratory grants ranging from \$10,000 to \$25,000. Our intention is to use learnings from a variety of grantee partners to help inform and further refine our areas of focus and the specific impact we seek to achieve through our giving.
	We use the following resources to guide our understanding of the communities in the U.S. and internationally that are most vulnerable to climate and other environmental challenges: <u>EPA's Climate Change and Social Vulnerability in the United States</u> and the <u>Global Climate Risk Index 2021</u> . We seek to support these communities and groups by distributing grants to organizations for new or existing efforts that contribute to healthy land use and regenerative ecosystems. We prioritize proposals that clearly integrate education and/or engagement efforts.
Evaluation	Grantees will be selected based on the following criteria:

Criteria

- Clarity of success: How is success defined? What are the expected results from this proposed grant and how will you measure the improvement in condition for the place or people served? Results are the incremental improvements in behavior or condition that are achieved as a direct result of the proposed efforts.
- Likelihood of success: How likely is it that the results can be achieved? Our focus is on factors such as past success of the organization, validity of the proposed approach, organizational capacity, and key personnel leading the proposed work.
- **Relationships in community** (including community partnerships and other supports, networks, and allies): *Are there strong community relationships in place to carry out the work?*

- **Mission alignment:** Does the proposal support a population identified by the Foundation as those most impacted by climate and other environmental challenges? Does the application clearly articulate how education and/or engagement efforts are utilized to achieve the intended results?
- Cost effectiveness: Does the proposed reach and impact seem commensurate with its cost?

Budget and
ProjectGrants will range from a total of \$10,000 to \$25,000 and are for a one-year
grant term. While the work can extend beyond the grant period, applications
must define a discrete set of activities that will be performed during the one-
year period.

Grantees will be asked to:

- share an update during one of the Foundation's virtual Board meetings in 2024;
- participate in two calls with the Foundation to share progress and learnings; and
- at the end of the project period, complete a grant report to articulate accomplishments, progress toward achieving intended outcomes, and learnings.
