Associate members include nonprofit organizations, consultants and professional advisors. Members in both categories receive the benefits of membership including access to programs and online resources.

In cases involving a member of MPC staff, the MPC president (or if the president has the potential conflict, the chair of the board) will determine whether or not there is a conflict of interest. An individual who is unsure whether his or her circumstances involve an actual conflict should err on the side of disclosure.
